Annexure II Due Diligence Process Note

We, the Book Running Lead Manager, have carried out a due diligence exercise in relation to the current business of Issuer for the purpose of complying with the requirement of SEBI ICDR Regulations and other applicable laws, and to the extent that is customary initial public offerings of this nature in India, along with other professionals and experts engaged in connection with the Offer.

The due diligence process carried out by us and the Legal Counsel to the Offer commenced with in-person and virtual interactions with the Promoters, Managing Director, Whole-Time Director, Senior Management Personnel and Chief Financial Officer, Company Secretary and Compliance Officer of the Company to gain understanding of the business of the Company, key risks involved, background of the Promoters and financial overview, among other matters for the purpose of the Offer. In this regard, the Issuer Company was provided with information requisition list prepared in consultation with the Legal Counsel (defined here-in after). In response to the questionnaire and information requisition list, the Issuer Company provided us with supporting documents for review and diligence and explanations with respect to our queries raised. In order to facilitate such review, the Company for review via emails, exchange of documents during physical visit and pendrive and provided explanations and supporting documents for review, such relevant documents were made available for undertaking the due diligence.

In the due diligence process, Chir Amrit Legal LLP, appointed as Legal Counsel to the Issuer as to Indian law (“**Legal Counsel**”) have assisted us in carrying out legal due diligence and drafting of Legal chapters of DRHP in compliance with the SEBI ICDR Regulations and other applicable laws, and advised us and the Issuer Company on legal matters, in relation to the Offer, including for the purpose of issuing legal opinions in relation to the Offer to us.

We were also assisted by the current Statutory Auditor of the Issuer, M/s. Ravi Sharma & Co. (the “**Statutory Auditor**”), in conducting the Financial Due Diligence. The Statutory Auditor have verified details and provided certifications with respect to certain other information included in the DRHP. In addition, the Statutory Auditor have provided a Statement of Tax Benefits to the Company and its shareholders, and/or has verified and certified certain matters relating to, inter alia, the computation of Company’s operating profit/loss, and/or certified certain matters relating to, inter alia, the computation of Company’s operating profit/loss, certain key performance indicators of the Company.

The Company has received written consent dated March 22, 2025, from the Statutory Auditor, who holds a valid peer review certificate dated March 17, 2022, to include its name as required under Section 26 of the Companies Act, 2013 in this Draft Red Herring Prospectus and as an “expert” as defined under Section 2(38) of the Companies Act, 2013 in respect of (i) the examination reports on the Restated Financial Statement dated March 22, 2025; and (ii) the Statement of tax benefits dated March 22, 2025, included in this DRHP and such consents have not been withdrawn as on the date of this DRHP.

The Company has also placed reliance on the report titled “Report on Indian Construction Industry” issued by Dun & Bradstreet Information Services Private Limited (“**D&B**”) dated March 05, 2025 and the report, the “**Industry Report**”/ “**D&B Report**”) for disclosures in the “*Industry Overview*”, “*Summary of Offer Documents*”, “*Risk factors*”, “*Management’s Discussion and Analysis of Financial Condition and Results of Operations*” and “*Our Business*” and various part in the DRHP. Further, the Company has received a written consent from D&B to include extracts of the Industry Report in the DRHP, Red Herring Prospectus and Prospectus and to include their name as required under section 26(5) of the Companies Act, 2013 read with SEBI ICDR Regulations, in this DRHP and as an “expert” as defined under section 2(38) of the Companies Act, 2013 to the extent and in their capacity as Industry experts, the same has not been withdrawn as on the date of filing of this DRHP. The Industry Report has been commissioned and paid for by the Company exclusively for the purposes of the Offer.

1. Business and commercial diligence:

The due diligence process in relation to general business and commercial matters included:

- a. Organizing and attending the kick off discussions to develop an understanding of the business and other matters of the Issuer Company’s management including the Promoters, Managing Director, Whole-Time Director, Senior Management Personnel, Chief Financial Officer, Company Secretary and Compliance Officer to develop an understanding of the business of the Company, industry, regulatory environment, history of the Company and other related matters. The discussion was attended by the team members of Book Running Lead Manager, the senior management of the Issuer Company, the Legal Counsel and Statutory Auditor. A broad overview of the business of the Company, industry in which it operates, regulatory framework with respect to the business, the corporate structure,

- the capital structure, and financial statements, its shareholding pattern and details of the Promoters of the Company was presented to us and Legal Counsel followed by interactive discussions;
- b. Providing the Issuer Company with a due diligence questionnaire and information requisition list prepared in consultation with the Legal Counsel, as is customary in such transactions. The Issuer Company provided the relevant documents, as appropriate, for review via emails, exchange of documents during physical visit and pen-drive and provided explanations and supporting documents for review.
 - c. Regularly interacting with the senior management of the Issuer Company and Statutory Auditor for the purpose of gaining an understanding about, amongst others, the business of the Issuer Company, the risks involved and a general overview and history of the Issuer Company. These interactions included (i) virtual and in-person due diligence meetings and calls, drafting sessions and conference calls to discuss the drafts of the disclosures proposed to be included in the DRHP, (ii) due diligence calls with the Statutory Auditor; (iii) seeking appropriate clarifications and certifications from the Company for key financial, operational data and other information; (iv) due diligence calls to receive updated information from the Issuer Company before filing the DRHP; (v) seeking appropriate certifications from Auditor for key operational data, amongst others; and (vi) seeking appropriate certification from the Company, Directors, Promoters, Key Managerial Personnel, Senior Management Personnel among others, for certain other information. These interactions were conducted with an objective to assist the Issuer Company to prepare disclosures as required under the SEBI ICDR Regulations, the Companies Act, 2013, and other applicable laws with regard to the Offer. We expect these interactions and due diligence calls to continue until closure of the Offer; Accordingly, disclosures in respect of the business carried out by the Company as well as associated risks in relation thereto, have been made in the sections titled "**Our Business**" and "**Risk Factors**" in the DRHP.
 - d. Virtual / telephonic interactions with the Key Managerial Personnel and Senior Management Personnel and to understand the Issuer Company's day to day operations and to verify the disclosures being made in the DRHP.
 - e. Requesting the Issuer Company, with the assistance of the Legal Counsel, to provide documents, based on the due diligence questionnaire and requisition lists, and reviewing these documents, which are required to be disclosed under the SEBI ICDR Regulations and documentation pertaining to material litigations of the Company as required under the SEBI ICDR Regulations. Reviewing such documents, including certain business agreements, documents in relation to insurance policies and intellectual property, along with the Legal Counsels, to comply with the diligence requirements as stipulated under the SEBI ICDR Regulations;
 - f. Obtaining and relying on certificates, confirmations, representations and undertakings from the Issuer Company on behalf of itself, the Promoter and members of the Promoter Group, each of the directors of the Issuer Company (the "Directors"), and other documents, including extracts of reports available in public domain, in support of certain disclosures made in the DRHP;
 - g. Obtaining and relying on formal representations and undertakings from the Company and the Selling Shareholders in the Offer Agreement;
 - h. For certain information, relying on management certificates from the Company for ensuring compliance with the SEBI ICDR Regulations;
 - i. Assisting the Company in obtaining the Industry Report from the D&B, commissioned and paid for by the Company for disclosures in relation to industry information in the DRHP. Further, necessary consent was obtained by the Company from the D&B to disclose the contents of its report in the DRHP.
 - j. Scheduling and attending due diligence / bring down due diligence calls with the industry report provider to understand the sources of information provided in the industry report.
 - k. Obtaining and relying on circle-ups from the Statutory Auditor on financial information and certain finance related information included in the DRHP as well as on certain financial, non-financial, operational and other business related information of the Issuer Company mentioned in the DRHP which were not part of the Restated Financial Statements.
 - l. Reviewed, together with the Legal Counsel, material agreements/contracts executed by, or in relation to, the Company and such other documents as we have deemed necessary and as have been provided to us by the Company, from time to time; and
 - m. Visiting the registered office and construction sites of Company for diligence purposes.

2. Risk Factors

We have studied the sector in which the Company operates and the risk associated with it. While the risks are inherent part of any system, we have put forth the risk associated with the Company, its business operations and other general risk. We have accordingly put forth risks (which we are aware of, and have been made aware of, and have discovered during the due diligence process) in the DRHP.



3. **Financial information of the Company and Financial Indebtedness:**

The Statutory Auditor was required to provide the Restated Financial Statements for the last completed three financial year and stub period for which the audit has been completed. We have interacted with the Auditor over a virtual diligence call and in-person meetings for the purpose of gaining an understanding about, amongst others, the risks involved and a general overview of the Issuer Company.

Further, the Statutory Auditor was required to review the financial information relating to the Company in the DRHP and have delivered a customary comfort letter and circle-ups to the BRLM confirming the accuracy of the financial information contained in the DRHP. Such comfort letter will be issued and/or brought down at certain future dates as the Offer progresses, by the Statutory Auditor, including on the filing of the RHP, the Prospectus and the Allotment of Equity Shares in the Offer. We have also obtained certifications from the Statutory Auditor in respect of certain financial matters pertaining to the Offer including a certificate to evaluate the eligibility of the Company and to undertake the Offer under Regulation 229(2) of the SEBI ICDR Regulations.

Suitable disclosures have been made in relation to key performance indicators of the Company which is disclosed in the section titled “*Basis for the Offer Price*” of the DRHP and other relevant sections in the DRHP in compliance with the amendments to the SEBI ICDR Regulations. Further, such key performance indicators were approved by the Audit Committee of the Company and have been certified by the Statutory Auditor.

We have relied on the Restated Financial Statement issued by the Statutory Auditor which includes the related party transactions which have been entered into by the Company in the preceding three financial years i.e. Fiscals ended March 31, 2024, March 31, 2023 and March 31, 2022 and for six months period ended September 30, 2024 together with all annexures, schedules and notes, that they are in accordance with applicable laws. Further, the Auditor has provided a statement of tax benefits available to the Issuer Company and its shareholders under the applicable laws in India, which has been disclosed in the DRHP.

As per the requirements of the SEBI ICDR Regulations, the Company has uploaded the Restated audited financial statements of the Company for six months period ended September 30, 2024 and Fiscals ended March 31, 2024, March 31, 2023 and March 31, 2022 together with all annexures, schedules and notes thereto on its website at www.goelconstruction.co.in. We have also obtained certifications from the Statutory Auditors in respect of certain financial matters pertaining to the Offer and the DRHP.

In relation to the information disclosed in summarized form in the section “*Financial Indebtedness*” of the DRHP, the relevant sanction letters and agreements issued by the lenders as well as other financing related documents were made available. The Company has also received written consents from its lender, granting their written consent to undertake the Offer and related corporate actions including *inter alia* issue and allotment of the Equity Shares and change in the capital structure of the Company. We have relied on a certificate from the Statutory Auditor to ascertain breakup of the outstanding borrowings of the Company as disclosed in the section ‘*Financial Indebtedness*’ on page 250 of the DRHP. The details of the borrowings availed by the Company and certain key terms are disclosed in the section Financial Indebtedness of the DRHP.

4. **The Company, Promoters, Promoter Group, Directors, Selling Shareholders, Key Management Personnel, Senior Management Personnel of the Company:**

For the purposes of making certain disclosures with respect to the Promoters, Promoter Group, Directors, Selling Shareholders, Key Management Personnel and Senior Management Personnel in the DRHP, supporting documents and certifications from the relevant entities / persons have been obtained.

For the purposes of disclosure of the educational qualifications and professional experience of Directors, Key Managerial Personnel and Senior Management Personnel of the Issuer Company, reliance was placed on degree certificates, experience certificates, affidavits and other back-up documents.

Confirmations have been received from the Company, the Directors, Selling Shareholders, members of Promoter Group stating that they have not been prohibited from accessing the capital markets under any order or direction passed by SEBI. We have also received certifications from (i) the Promoter (on behalf of itself and members of the Promoter Group) and (ii) the Directors confirming that they have not been prohibited from accessing the capital markets under any order or direction passed by SEBI. Further, we have received a confirmation from the Promoters and Directors of the Company

that they are not a promoter or director of any other company which is debarred from accessing the capital market by SEBI. Further, we have received confirmation from the Company, its Promoters and Directors that they are not declared as wilful defaulters or fraudulent borrowers as defined under the SEBI ICDR Regulations. Further, confirmations have been taken from Directors that (a) they are not directors on the board of other listed companies whose shares have been / were suspended from being traded on the BSE Limited and/or the National Stock Exchange of India Limited during the period of 5 (five) years before the date of the DRHP; (b) that they are not currently or were previously on the board of a listed company whose shares have been or were delisted from being traded on any stock exchange while they were directors of such companies. Further, we have received confirmations from the Directors and Promoters that they are not identified as a 'fugitive economic offender' as defined under the SEBI ICDR Regulations.

Confirmations have been received from the Issuer, Promoters and Promoter Group in respect of their compliance with the Companies (Significant Beneficial Ownership) Rules, 2018, as on date of the DRHP, to the extent applicable.

The term "group companies" under the SEBI ICDR Regulations includes companies (other than the promoters and any subsidiaries) with which there were related party transactions, during the period for which financial information is disclosed in the offer documents, as covered under the applicable accounting standards, and also other companies as considered material by the Board of Directors of the Company. The Board of Directors of the Company has, through a resolution passed at its meeting held on March 12, 2025, adopted a materiality policy for identification of group companies ("**Materiality Policy**"). In terms of the aforementioned Materiality Policy, it is clarified that group companies of the Company shall include (i) companies (other than the subsidiaries) with which there were related party transactions, during the period for which financial information will be disclosed in the Offer Documents, as covered under the IGAAP; and (ii) companies as considered material by the Board pursuant to the materiality policy, as 'group companies' of the Company.

The Selling Shareholders, in relation to the notice for participation in the offer for sale, containing terms and conditions for the Offer including eligibility conditions for participation in the Offer, the Company has received consent letters, along with the relevant information and documents which include, authorization from each Selling Shareholder to participate in the Offer and various confirmations, covenants, representations and warranties, as required from each Selling Shareholder.

5. **Outstanding Litigation Proceedings and Material Creditors**

The Company has disclosed outstanding litigation involving the Company, Directors, Promoters (as applicable) on the basis of the legal requirements under the SEBI ICDR Regulations read with amendments thereto and the Companies Act, 2013 and in accordance with the policy on determination of material litigation ("**Materiality Policy**") approved by the Board of Directors ("Board") of the Company in its meeting held on March 12, 2025. Further, there are no disciplinary actions including penalties imposed by SEBI or stock exchanges against the Promoters in the last five (5) financial years including any outstanding action. Furthermore, interactions have been conducted, from time to time, with the relevant representatives of the Company to understand the status of material pending proceedings involving the Company.

We have disclosed outstanding litigations in accordance with the legal requirements under SEBI ICDR Regulations i.e. matters involving

- (i) issues of moral turpitude or criminal liability on the part of the Issuer Company;
- (ii) material violations of statutory regulations by the Issuer Company;
- (iii) economic offences where proceedings have been initiated against the Issuer Company;
- (iv) any pending matters, which if they result in an adverse outcome, would materially and adversely affect the operations or financial position of the Issuer Company; and
- (v) other litigation, including civil or tax litigation proceedings, which involves an amount in excess of the Materiality Threshold (as defined below) or is otherwise material in terms of the 'Policy for determination of materiality of information or event' framed in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 in case involving the Company, the Selling Shareholders, Directors and KMP/SMP.

The materiality threshold ("**Materiality Threshold**") adopted for civil and tax litigation, solely for the purpose of the Offer, was, all the pending material civil and tax litigation proceedings involving (i.e., filed by or against) the Company. The materiality threshold in relation to litigation proceedings as approved by the Board of the Company has been disclosed in the DRHP.

We had conducted litigation, watchout and CIBIL searches for the Issuer Company, Directors, Promoters, KMPs and SMPs and have disclosed the risk factor on litigation titled "*Risk Factor No. 7. Our Company, our Promoters, and our Directors are party to certain legal proceedings. Any adverse outcome in such proceedings may have an adverse impact on our reputation, business, financial condition, results of operations, and cash flows*"

Based on the Materiality Policy adopted by the Board, disclosures on material and other creditors have been included in the DRHP. The disclosures on dues to other creditors and to micro, small or medium enterprise (as defined under the Micro, Small and Medium Enterprises Development Act, 2006) have been provided indicating the total number of, and aggregate outstanding amounts due to such creditors, based on the certificate obtained from the Statutory Auditor. Interactions were conducted with the relevant senior management of the Company to understand the status of material pending proceedings involving the Company.

6. Approvals, Licenses and Registrations

Given the extent of the operations and management by the Issuer Company, we have restricted the extent of our diligence, from the perspective of approvals, licenses and registrations and review of property documents, material to the Company in a consolidated manner.

7. Industry Overview

We have relied on the industry and market data derived from the D&B Report. The D&B Report has been commissioned and paid for by the Company exclusively for the purposes of confirming the Company's understanding of the industry in connection with the Offer. The information contained in certain sections of the DRHP, including "Risk Factors", "Industry Overview", "Our Business" and "Management's Discussion and Analysis of Financial Condition and Result of Operations", have been included from this report. The Industry Report will be available on the website of the Company at www.goelconstruction.co.in in accordance with applicable law and has been included as one of the documents that will be available as a material document for inspection.

8. Objects of the Offer

The Offer comprises of Fresh Offer of up to 30,85,000 Equity Shares and Offer for Sale of up to 7,25,000 by the Selling Shareholders of the Company.

The Objects of the Offer include to i) Capital expenditure towards purchase additional equipments and fleets ii) Repayment / prepayment of outstanding borrowings availed by our Company and iii) General Corporate Purpose

The Issuer proposes to utilize upto ₹ 4,300 Lakhs out of the Net Proceeds towards such purchasing equipment and fleet which includes (i) Batching Plant- M30Z, (ii) JCB 440, (iii) Tower Crane, (iv) Boom Pump etc. The Issuer does not intend to purchase second-hand or used equipment and fleet out of the Net Proceeds. Each of the units of capital equipment and fleet mentioned above is proposed to be acquired shall either be assembled on site or shall be in a ready-to-use condition.

Further, the Issuer proposes to utilize an amount of up to ₹ 2,431.34 lakhs from the Net Proceeds towards repayment/prepayment of the Equipment and Fleet Loan availed by the Issuer Company. In case of rundown of the outstanding amount due to payment of instalments, the amount of shortfall, if any, will be either used in repayment and prepayment of any other similar loan or used for General Corporate Purpose in accordance with SEBI ICDR Regulations and other applicable laws.

Further, The Net Proceeds will be first utilized towards the Objects as mentioned above.
